6. Gain understanding of the evidence supporting orthoses as a therapeutic intervention

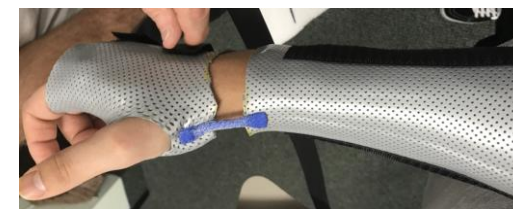


## Instructor
